CEE Digital Summit Warsaw 2021 Proclamation

We, the organisations representing the digital and advanced technologies industry of Central Eastern European countries, building on the foundation of Warsaw Digital Declaration of 2020, wish to restate its ideas and proclaim the conclusions of CEE Digital Summit Warsaw 2021. Staying deeply engaged in our efforts for building digital competence, driving investments in advanced technologies, striving for common access to the internet, digital services and development of fifth generation mobile networks as well as responsible data management, we uphold our support for start-ups and SMEs of Central Eastern Europe and development of uniform and clear regulatory environment, driving the digital economy in our region.

We acknowledge further rapid changes across the economy and society accelerated by the pandemic and the burning need for universal adoption of the digital transformation. Thus, concluding the gathering of CEE Digital Summit Warsaw 2021, we want to accentuate the fundamental value of national and regional work towards:

Growth of the digital economy by providing a fair regulatory landscape

A coherent regulatory policy that is facilitating growth of our countries' and region's digital economy must be secured in order for Central Eastern Europe to remain competitive, overcome the struggle of post-pandemic crisis, achieve resilience and rise to the top of global economic stakes by allowing growth of innovative, local enterprises. We call for deep regional policy-making cooperation in order to make the upcoming Digital Services Act (DSA) and Digital Market Act (DMA) forward looking and not limit the access of regional users to the state-of-the-art technological solutions. We hope that awareness of the digital economy's significance will be expressed not only by a cautious regulation, showing understanding for a diverse environment of digital services, but also by funding opportunities supporting regional enterprises. A truly common approach and a unified front will greatly benefit our region's society and set the foundation allowing growth of the digital economy and thus, Central Eastern Europe as a whole.

Regional, widespread adoption and development of the latest technology
